## Second Unitarian Church of Omaha Rules for the Annual Meeting

The Handling of a Motion:

- A member makes a motion. ("Member" means voting member of the Church.)
- Another member seconds the motion.
- The chair states the question on the motion.

Neither the making nor the seconding of a motion places it before the assembly; only the chair can do that (with step 3). When the chair has stated the question, the motion is pending and is open for debate.

Members debate the motion (unless no member claims the floor to do so). During debate, no one shall speak more than two minutes (unless the assembly declares its desire to waive this rule for a specific speaker). No one is entitled to the floor a second time on the same motion as long as any other member who has not spoken on this motion desires the floor. With the permission of the chair, a non-member may participate in debate (please identify yourself as a non-member when recognized by the chair, so there is no confusion).

The chair asks if there is any further discussion and, if there is not, puts the question to a vote, calling for those in favor, those opposed, and those abstaining.

The chair announces the result of the vote.

During the debate on the motion, a member may call for the "question," which is a request to close debate and proceed to a vote. The chair may observe that the question has been called and ask if there is any objection to closing debate. If there appears to be significant objection, the chair may allow the debate to proceed. If a member wishes to press for closure, she/he may seek recognition and "move the previous question." This is a priority-taking motion, which, if seconded, must be voted on immediately. If it carries by a 2/3 majority, then debate on the previous motion is terminated, and the chair proceeds immediately to put the previous question to a vote. Otherwise, debate on the previous motion continues.

In cases of questions on parliamentary procedure, the chair shall rule. If the ruling is contested, the assembly shall vote on whether or not to uphold.

#### Minutes of the Annual Meeting Second Unitarian Church of Omaha May 22, 2011

- 1. **Call the Meeting to Order**: Tom Peterson, Board Chair
- 2. Opening Words and Chalice Lighting: Rev. Scott McNeill, Minister.
- 3. **Confirmation of Quorum**

*OUTCOME*: Lorraine Duggin, secretary, confirmed quorum. 6 absentee ballots, not counted to the quorum, were also received. A motion was also passed to amend the minutes from last year's meeting to the correct date of May 23, 2010.

OUTCOME: Vote passed unanimously.

5. Presentation and election of slates of nominees.

Nominations and Leadership Development: Richard Koelling, to replace Joanne Draper (3 year term)

*OUTCOME*: Steve Abraham presented the slate, which was moved for acceptance by Gene Kopecky and seconded by Janet Nichols. The slate was passed with 1 abstention.

6. Presentation and vote on annual budget for 2011-2012

OUTCOME: After a brief discussion, the vote passed unanimously

7. Approval of Delegates for General Assembly (3 allowed)

*OUTCOME*: Clyde Anderson moved and Darrell Draper seconded to elect Don Shennum as a delegate to the General Assembly in Charlottesville, NC. In June and to permit the Board to name two other delegates. (Assuming that two other 2nd UU members are going and are willing to be delegates.) Outcome was unanimous.

8. Discuss Possibility of moving to Two Sunday Services

*OUTCOME*: After considerable discussion following a presentation by Rev. McNeill, the congregation voted to approve the proposal with 43 approving, 2 opposing. Motion carried. Rev. McNeill added a friendly amendment to report back to the congregation by June 19 on the details of the two services format.

The Nominations & Leadership Development Committee: Sue Aschinger (Chair), Steve Abraham, and Richard Koelling, have completed our mission of developing a slate of candidates for the upcoming Annual Meeting in May. We are very excited about the candidates we are presenting for the open positions on the Board, Nominations & Leadership Development Committee, and Endowment Fund for your consideration.

The committee is also challenged to facilitate leadership development for the congregation. We support not only finding qualified candidates for our elected positions, but also helping to find and grow current and future leadership for our various committees and programs. In order to understand these needs, during this past year, we conducted a needs assessment of each group. We are now in the process of reviewing that information to develop a leadership growth plan for the congregation. This includes training needs to ensure our congregation's continued vitality and growth.

We are proud to submit the following nominees to you: for Board, the two candidates are Michael Lynne and Bill Kuhn; for Nominations and Leadership Development, Carol Johnson; and for Endowment Fund, Don Mundy. All of our nominees have served in various capacities in the Church and have a true passion for our mission and vision. This year, we will be replacing two of the three board members whose terms are expiring in June 2012. This is in anticipation of a by-law change to in the total number of board members.

Each candidate has provided the following biographies so that you will be more familiar with each of them from a personal perspective, their church experience, and their thoughts about our church.

#### Bill Kuhn Board of Trustees, 3-Year Term

Born and raised in a small town in Louisiana, where I graduated from High School. I graduated from Southern Illinois University, BS Electronics and Management; also have a BS in Automotive Technology, (but I don't change the oil in my own car).

Retired from United States Air Force after twenty years of active duty, I have been fortunate (or not) to visit many places. Some I can mention, and some I am unsure of the actual location, because based on my observations, the terrain did not match the destination on paper documents. Suffice it to say, that I have been on all the continents except Australia, and the Antarctic.

Interests and hobbies: Playing guitar and singing, LGBTQ Rights Activism, Social Justice. My interest in liberal politics, and social justice, is a result of observing my parents, who were not afraid to support and care for people of color, even though this was not a popular activity among neighbors. It was OK to be "Different" than the folks around us.

I feel that as a board member I will bring a perspective as someone who is somewhat new to our community, but sharing the views of many who are long-time members. As a new member, I still have much to learn on my journey and I look forward to continuing my growth at Second Unitarian. Our community is very important to me, and I want to see it grow and continue to be a refuge for those seeking to find community as I have.

While I do not feel that I will be able to assume a leadership position on the board, at this time, I still feel I can add value and be a contributing member of the board, advocating for social justice and technology, and acting as a liaison for these and other interests.

#### Michael Lynne Board of Trustees, 3-Year Term

I grew up in Westchester County, just north of New York City, as the oldest of three children. My father, an alcoholic, deserted us when I was 12. I paid my way through Hartwick College by working as a paper boy, in a stationery store, as a janitor and truck loader for Avon Products and with scholarships and loans. Always a reader, I majored in English and later earned two masters degrees at

Binghamton University in upstate New York. I taught junior-high and high-school English and later became a staff developer. After earning an administrative certificate, I became an elementary principal and director of special education, finishing my career in a small district at the tip of Long Island in New York.

Cindy and I were in the same seventh-grade class, and our mothers grew up on the same street in Larchmont. We met again when I cleaned the department in which she worked at Avon. We have three daughters. Our oldest Heather and her husband Scott live in Elkhorn and have two daughters Marie (6) and Katie (5). Our middle daughter Johanna is a psychiatric nurse at the San Diego Veterans Hospital. Our youngest Jessica and her dentist husband Tom live in Kingston, New York, and have recently had our first grandson Lyndon. I enjoy my involvement with my grandchildren, volunteering as a mentor at Fire Ridge Elementary in Elkhorn, gardening and home maintenance, and an occasional round of mediocre golf. Of course, I still read widely in literature, history, religion, and -- too much -- politics and current events.

Although raised as a Presbyterian and confirmed as a Methodist, I have not been affiliated with a church during my adult life. Always a spiritual seeker, I practiced Transcendental Meditation and explored other spiritual traditions but have never found a spiritual "home." Second Unitarian Church is the first church where I have felt a shared spiritual and social justice mission that answers to my own needs. My work as a Worship Associate has been extremely satisfying, for which I am grateful. The sense of a communal mission, whether it be at the annual house painting, church clean up, working on the Committee on Ministry for Rev. Sarah Gettie Burks, the hiring committee for the Director of Religious Education, or the Stewardship Kickoff Event Committee has contributed to my own spiritual and social development. The people of 2U are its greatest asset. It has been a privilege and a continuing satisfaction to work with and get to know them better.

Obviously, a small church such as ours needs to continue to provide for the spiritual, social, and social justice needs and interests of its members by continuing to involve them in all aspects of church life. At the same time, we need to reach out to potential members in order to grow both in numbers and to enrich our spiritual and social ministry. An essential step in the long-term evolution of 2U must be to upgrade our current facility. It is inadequate to our current needs

and blocks our ability to fulfill our mission and to attract and hold new members. At the same time the Board needs to maintain its tradition of prudent management of resources, monitoring of all aspects of church mission and functioning, and adjusting programs, personnel, and priorities as necessary. It would be an honor to serve on the Board and assist in the continuation and development of this unique and precious institution.

#### **Carol Johnson**

#### Nominations and Leadership Development, 3-Year Term

Since joining Second Unitarian in 2005, I have served on several committees and leadership groups including Stewardship, Communications (Marketing), Personnel, Social Justice and Board of Trustees. #### **Bylaws Revisions**

**Bold text** are changes and [bracketed/underlined text] are deletions.

Article 3. Mission Statement

[Second Unitarian Church of Omaha is an inclusive and nurturing religious community engaged in thoughtful pursuit of truth and meaning. Our mission is to grow as a beacon of hope – sharing a vision of a world community that embraces diversity, justice and

respectful stewardship within the interdependent web of existence.]

Our Mission is to be Authentic, Compassionate and Transformative in our lives, in our faith, and in our world.

Rationale: This is the new mission statement as forged through discussions held with church committees, Program Council, Board of Trustees, and Committee on Ministry.

Article 5. Membership

Section 5.6. Termination of Membership.

Any Member who moves away from Omaha or its vicinity or who chooses to withdraw membership, can request that their name be removed from the current membership list and their status changed to former member by sending written notice to the Secretary. The Board of Trustees may direct that Members whose status has been listed as non-voting for 12 months, who have not made a recorded financial contribution during that time, and who do not respond to

attempted contact within 30 days be removed from the membership list and their status be changed to former member.

Rationale: It was pointed out to the Board that since creating the status of "Non-Voting Member" in 2010, inactive non-voting members tend to stay on the rolls indefinitely because there has been no provision for the Board to remove their names from the rolls.

Article 7. Board of Trustees

Section 7.1. Selection and Term.

The governing body of this church shall be a Board of Trustees consisting of [eight] six members elected for threeyear terms by the church membership. Two elective Trustees shall be elected [once every three years and three all other years for three year terms each year at the annual meeting] annually. [The terms shall be staggered so that the terms of two Trustees begin each third year and three on all other years[. No person who has served four successive years on the Board of Trustees is eligible for election or appointment until that person has been absent from the Board for a period of not less than one year. No more than one family member from the same household shall serve on the Board of Trustees at the same time. No member of the congregation shall be eligible to serve on the Board of Trustees if a family member from the same household is an employee of the church. If the number of candidates for election to the Board of Trustees exceeds the number of seats to be filled, then voting at the annual meeting shall proceed by secret ballot with each voting member present at the meeting allowed to vote for a number of candidates equal to the number of seats to be filled. The candidate(s) receiving the highest number of votes shall be elected. There shall be separate nominations and elections for the regular three-year terms and for any unexpired terms. Terms of office for elective Trustees shall begin July1, following their election at the annual meeting. All Trustees shall have been Members and actively involved in the Church for at least two years prior the start of their terms and be prepared to attend the June Board meeting for orientation.

Rationale: The Board of Trustees recommends changing the membership of the Board from eight members to six. It had been increased to eight several years ago when board members were liaisons to committees and expected to attend those meetings each month. The governance structure is evolving toward a program council model which no longer requires board attendance at committee meetings. This change is also consistent with wider trends in governance toward smaller governing boards that are focused on policies and vision, rather than more direct operations of the church. Having an increased membership on the board also drains committees of potential leaders.

[Subsection 7.1.a. Transition from two-year terms to three-year terms.

The change from two-year terms to three-year terms of members of the Board of Trustees shall not affect the length of term on the Board of any member elected prior to the 2008 Annual Meeting. At the 2008 Annual Meeting, to maintain an eight-member Board, four trustees shall be elected; two for three year terms and two for two-year terms. At the 2009 Annual Meeting, four trustees shall be elected; three for three-year terms and one for a one-year term. At the 2010 Annual Meeting three trustees will be elected for three-year terms.]

Section 7.6. Specific Responsibilities.

7.6.d. Appoint [committee chairs in cooperation with members of the committee.]

members to the Endowment Committee.

Rationale: Currently the by-laws state that the Endowment Committee consists of 3 members who are elected by the voting members of congregation at the Annual meeting. The Nomination Committee is suggesting that the bylaws be amended to make the Endowment committee a board-appointed position. The Nominations committee could still be involved to make recommendations to the board; but the board would ask the member. It would still be a committee of three, with 3-year terms, and one person revolving off every year and a new member being appointed.

Article 8. Officers of the Board of Trustees

Section 8.2 Duties of the Officers.

8.2.c. The Secretary shall keep full records of all actions of congregational meetings and of the Board of Trustees, shall cause notice to be given of all meetings as provided in the Articles and By-Laws, shall maintain a current roll of voting members of this church and be responsible for certifying voting members as required at membership meetings, and shall distribute and [maintain records for keys] provide for distribution and maintenance of records for keys/key codes to the church. The Board Secretary shall set apart in a prominent place in the church, a Membership Book that shall be headed by the Articles of Incorporation.

Rationale: In practice, the office administrator maintains records of keys and key codes, under the direction of the Board secretary.

Article 9. Nominations and Leadership Development Committee

Section 9.2. Calls and Recruitment.

The Nominations and Leadership Development Committee shall make an open and active call for candidates to run for election to the Board of Trustees, **Endowment Fund Committee**, and the Nominations and Leadership Development Committee, and also for candidates for positions that are appointed by the Board of Trustees. Church Members may nominate themselves or any other Member with the Member's consent.

Section 9.3. Duties.

The Nominations and Leadership Development Committee shall publish the names of the nominees for the Board of Trustees, **Endowment Fund Committee**, and the Nominations and Leadership Development Committee which are to be filled by election at the annual meeting, in sufficient time to send to the membership not less than seven days before the Meeting. **They will coordinate with other church leaders for leadership development as appropriate.** 

Rationale: The proposed last statement reflects a current expectation of this committee.

Article 10. Minister

Section 10.6. Dismissal of Minister.

Failure of the Minister to follow [Board of Trustees] Church policies, loss of confidence By the Congregation, or unprofessional behavior shall be grounds for recommending the dismissal of the Minister. The Board of Trustees, or twenty-five church Members by petition, shall call a congregational meeting for consideration of the dismissal of the Minister. A majority vote is necessary for dismissal or the acceptance of a resignation. Voting shall be by written ballot.

Rationale: Correction to "Church" policies, rather than "Board" policies.

Article 14. The Endowment Fund Committee (EFC)

Section 14.2. EFC Membership.

The Endowment Fund Committee shall consist of three (3) members, all of whom shall be voting Members of the Second Unitarian Church of Omaha for a minimum of one (1) year prior to the start of their term on the committee. One member will be [elected ]appointed each year by the Board of Trustees [at the Annual Meeting]. The term of each member shall be three (3) years. No member of the EFC shall serve more than two (2) consecutive three (3) year terms. After a lapse of one (1) year, former EFC members may be [re-elected] reappointed. The Minister, the Chair of the Board of Trustees, and a representative from the Finance Committee shall be advisory, nonvoting members of the EFC.

Rationale: Proposed revisions reflect Nominations committee recommendation for Board appointments, and clarifies eligibility for membership to the committee.

[Section 14.3. Nominations.

The Nominations and Leadership Development Committee shall nominate new members for the EFC.]

Section 14.4. Vacancies.

In the event of a vacancy on the EFC, the Board of Trustees shall appoint a qualified member of the Congregation to fill the vacancy [until the next annual meeting, at which time the Congregation shall elect a member to fulfill the term of the vacancy].

Section 14.5. Meetings.

The EFC shall meet at least quarterly, or more frequently as deemed by it in the best interest of the Endowment Fund. A quorum shall consist of three (3) members. A majority present and voting shall carry any motion or resolution. [Upon election by the Congregation at the annual meeting,] The EFC shall elect from its own membership a chairperson, financial secretary, and recording secretary. The chairperson, or member designated by the chairperson, shall preside at all EFC meetings.

#### Parish Minister, Rev. Scott McNeill

#### **Summary of Achievements**

- Provided leadership as the church moved to two worship services on Sunday mornings. While difficult in many ways, we worked well to adapt to this major change and allow for more people to join us in worship. Our attendance rose greatly due to this new worship service – and it has taken a lot of work on the part of volunteers and staff, but we have been greatly served by this folks who did help us on Sunday mornings.
- Last year (2011), I suggested to our Board, Social Justice
  Council and Finance Committee that we undertake the "Share
  the Plate" program that so many UU churches organize. Since
  starting it in the fall of 2011, it has been a huge success, sharing
  our resources with the community and getting our name out to
  other organizations.
- Part of my ministry has been to work with our larger Association.
  In addition to regular clergy gatherings, I have served on our
  Association's committee to address Anti-Racism, AntiOppression and Multi-Cultural work. Additionally, I was chosen
  to serve on the committee to nominate the Moderator (chair of
  the Board, convener of General Assembly) for the UUA. Both
  positions have been great work and further our ministry by
  helping to grow our faith, helping to educate me as a minister,
  and in building connections.

- Rev. Burks has completed a fourth unit of Clinical Pastoral Education through the University of Nebraska Medical Center. This allows her to pursue becoming a Board Certified Chaplain through the Association for Professional Chaplains. It also creates opportunities for her to learn more about CPE Supervisor training.
- Rev. Burks has participated in several committees in her hospital work, including Patient Rights and Ethics, the Ethics Education Team, Diversity Committee, Harper's Hope (Cancer support services), Integrated Oncology Team, De-escalation Training, and the Women's Hospital Council. Additionally, she has worked with Second Unitarian's Caring Committee and is interested in establishing a health ministry program with other members of the church.

#### **Summary of Achievements**

 Based on the feedback from the facilitated joint meeting of the Committee on Ministry, Program Council and the Board of Trustees in January 2011, the Board crafted a mission statement and a vision statement to guide the work of the board, committees and the congregation. The mission statement that the board will be presenting to the congregation on May 20 is:

Our Mission is to be Authentic, Compassionate and Transformative in our lives, in our faith, and in our world.

And this vision statement for Second Unitarian Church:

Authentic, Compassionate, Transformative Second Unitarian Church encourages people to live with integrity, to nurture one another, and to change the world through acts of love and justice.

We minister to each other through vibrant worship, religious growth and learning, and a commitment to advocacy, witness and action.

We come together to comfort and to challenge. We enrich our lives by weaving together our personal experiences, theologies and practices into one larger tapestry. The board looks forward to the many ways we will live out this mission and vision together as a congregation.

- Revisit/update the long range plan completed in 2004. As the number of members grew in the past year a switch was made to two worship services to accommodate a more crowded sanctuary. However, more members and more activities also led to more difficulty in securing space for church meetings/activities, thus the board decided more action needed to be taken. In January 2012, the board met with Prairie Star District Executive, Nancy Heege, and she recommended that our first step be an update of the existing long range plan rather than implementing the traditional method for long range plans that requires 18-24 months for completion of a new plan. The major goal from the 2004 plan that was not implemented was the securing of a building for the congregation that would be accessible; have adequate worship, meeting, fellowship, and office space; and have attractive religious education areas.
- To that end, the board invited UUA campaign consultant, Dave Rickard, to do an assessment of the congregation's resources to move towards a more suitable building. He made that visit on April 20-22, 2012 and has recommended that the board select a long range planning committee to update membership growth and financial projections as well as a membership development plan to guide us as we proceed with this effort. He also recommended a building planning committee be selected to reassess building needs, update as indicated, and then prepare criteria for a new space. The consultant's report/recommendations will be presented to the congregation on May 20 for consent to proceed.
- The board has been exploring the future trends for congregations and has made a commitment to enhance our knowledge on these topics through webinars, workshops, and reading together and discussing a common book. Our goal is to be more creative in our thinking about how we guide the work of the board and committees to be ready to meet the changing needs of the congregation and the greater community.

#### <u>Director of Religious Education,</u> Kirsten Stiles

#### **Summary of Achievements**

- The transformation that goes along with switching to two services has been key to several changes to the organization of the Religious Education program.
- We started the year by offering two RE classes for the first service and one for the second service. During the first service we offered RE to Pre K-1<sup>st</sup> and 2<sup>nd</sup> – 6<sup>th</sup> grade. For the second service we offered RE for only Pre K -1<sup>st</sup>.
- After the first of the new year we combined the classes. We began an all ages classroom style for each service thus providing RE classes for all children and during both services. The children seem to enjoy the warmth of everyone able to gather together to light the chalice.
- Each week's lesson is presented on several different learning levels to accommodate each child's learning stage, as a younger child can learn so much from observation alone of an older child. That encourages the older children to act as role models and allows the younger children to learn at their own pace with new challenging ideas to be explored right at their fingertips.
- We welcomed Molly Wilson to our team from First Unitarian Church of Omaha in February. Molly is our new Childcare Coordinator.

#### **Summary of Achievements**

Thanks to Don Shennum for leading the website task force and the Communications Committee and Technology Committee working together to make the new website happen. Special thanks to Kathy Bell for her helpful training.

In addition, I'd like to mention two exciting, but rather unpleasant, events of the past church year.

#### Flood of June 2011

 We experienced water in the lower level following a heavy rainstorm on June 26. I arrived to find puddles of water and soaked carpeting. Both Rick Bell and Clyde Anderson were out of town, so Tom Rundquist, on call for Building & Grounds, spent much of the week following up, including renting a dehumidifier and contacting a water remediation company to make sure we'd done everything right (and we had!) B&G checked on the cause and how to avoid water in the future.

#### Fire of July 2011

• The very next month, we had a fire at our Community Garden. Several neighbors pounded on our doors and alerted us while other neighbors tried to put out the flames with water and small fire extinguishers. Someone had already called the fire department, which quickly arrived and put out the fire. According to one fireman, and confirmed by Larry Kurtz, the fire was apparently caused by spontaneous combustion in the hay bales surrounding the garden. The garden committee folks removed the hay that evening.

#### **LGBTQ Welcoming Congregation Committee**

 In February, we began hosting a monthly transgender youth group meeting at the church. The group is still in its evolutionary stages, but thus far we've had about 20 non-member attendees, along with about 10 members who've participated. Some have come from Lincoln, as well as many from the Omaha area. Our goal is to provide a safe and nurturing space for transgender teens, young adults, and children, as well as their families and friends. We begin with a potluck lunch, then have a focused activity, as well as unstructured time to share with one another.

- In October, we hosted a **Dessert and Book Signing for** In My Shoes: Teen Reflections on Hope & the Future. This book of personal essays was authored by South High School students who had been in Committee member Ferial Pearson's English classes. Many of the students, as well as some of their families, attended the Book Signing.
- Our members were active in supporting the passage of the extension of Omaha's non-discrimination ordinance to include sexual orientation and gender identity.
- Participated in the Annual Pride Parade and Festival

#### **Closing the Economic Gap/Economic Justice**

The group is working with members of other OTOC congregations. On April 15, 2012, a non-partisan candidates forum for US Congress was held at North High School. The forum was sponsored by the Interdenominational Ministerial Alliance, the North Omaha Empowerment Network, and OTOC. Issues addressed with candidates included Health Care, Education, Workforce Development and Jobs, Immigration Reform and Youth.

#### **Additional Justice-Making**

Share the Plate Program: One half of the offering each Sunday will be given to a non-profit outside organization. In the first eight months of the program, \$4,647.65 was received and then donated to the following organizations: Neighbors United Community Meal (2); UUA Association Sunday; Justice for Our Neighbors-Nebraska; Nebraska Aids Project; Ministers Discretionary Fund; Together Inc; Siena Francis House; Tom Mahony Pride Prom and Food Bank for the Heartland.

<u>Social Justice Movie Nights</u> are opportunities to provide education in a variety of justice areas. Each of the movie nights was well attended and included discussion or panels to provide further insight for the participants.

Rev. Scott McNeill and the Music and Worship Committee selected Social Justice as the theme for January's Sunday Services Worship.

**2011 Paint-A-Thon:** This was our fifteenth year participating in Brush-Up Nebraska's Paint-A-Thon. We received feedback from the

homeowner whose house we painted in August. The homeowner was most appreciative of the work. Volunteers from Second Unitarian and First Church participated.

<u>Co-sponsored with Project Interfaith</u>, the "Then and Now: Civil Liberties and Interfaith Relations Ten Years After 9/11" held on 9/11/2011.

Immigration: A Moral Issue discussion series, led by Carol Johnson, was attended by 8-15 members and friends and included: Understanding the Causes of (Im)migration; The History of (Im) migration in the U.S.; Economic Pressures Around (Im)migration; Security, Enforcement and Human Rights; Who Benefits From a Broken System? Seeking Solutions. The discussion series was kicked off with a documentary entitle "abused: The Postville Raids."

#### <u>Omaha Together One Community – broad based community organizing</u>

**Just and Comprehensive Immigration Reform** 

Members of Second Unitarian were part of the diverse group of 450+ Omahans in attendance at an Immigration Forum on 9/26/11 where we learned how we can work together to improve the treatment of immigrants in Nebraska. OTOC's Immigration Action Team worked with 10 Omaha area



Senators to express our opposition to "Arizona style" immigration legislation introduced in the Unicameral. OTOC Leaders worked with Omaha Senators, members of the key Judiciary Committee who led the opposition resulting in all immigration bills being held in committee for the 2012 session. The Action Team has held training sessions in 15 different institutions involving over 800 people who came to learn more about this issue where participants learned more

about the challenges facing immigrant families, the need for comprehensive immigration reform and the problems created by adoption of a patchwork of state laws concerning immigration.

#### **Neighborhood Revitalization**

Housing Action Team worked to encourage the City of Omaha to raise the re-inspection fee when homes are found to be in violation of city housing codes. OTOC leaders learned that there are over 4,000 open cases where property owners have failed to make repairs once a housing code violation was found. Nearly 70% of these violations are in rental properties and many are longstanding violations. OTOC met with council members to explain why the \$41 fee needed to increase as a way to turn up the heat on negligent landlords. Responding to OTOC leaders and allies who testified, all seven Council members voted at their October 25th meeting to increase the re-inspection fee from \$41 to \$125 over the next 3 years. OTOC leaders continue to seek ways to improve housing.

#### **Jobs and Workforce Development**

OTOC's Workforce Team is working to improve customer service and job training at the federally funded workforce center located at 24th and Lake Street. OTOC joined with the Interdenominational Ministerial Alliance (IMA) to put pressure for improvement on the agencies responsible for managing the center. Mayor Suttle appointed Heartland Workforce Solutions (HWS) to assume management of the center and OTOC and IMA have met with the new management on a regular basis and attended board meetings to express our concerns.

#### **Alliance Schools Increase Parent Engagement In Education**

OTOC's Institute of Public Life (IPL) has partnered with several OPS schools to help parents learn how to participate more actively in the education of their children. Parents have worked with OTOC on a variety of strategies to engage parents in working to improve the climate for education in their school, communities and homes. Each group of parents determines their own priorities and parents have organized events such as a Family Heritage night for the diverse families at Kellom and immigration workshops at Spring Lake with lawyers and the Mexican Consul. Parents at Gomez have worked to develop a Pathways to College Leadership Academy to better

understand how to help their children succeed in school from kindergarten through college.

Refugee Leadership Academy Teaches New Skills, confidence After holding house meetings with 150 of the 20,000 African and Asian refugees living in Omaha, OTOC's Refugee Support Action Team recognized that many refugees face daunting challenges as they attempt to settle their families here. The Action Team has organized a Refugee Leadership Academy which meets to help refugee leaders understand how to help their communities address fundamental issues. So far, over 40 refugee leaders from 7 different communities have participated in 2 rounds of training sessions. Refugee leaders are currently working with OTOC leaders on improving housing code enforcement at apartments with high concentrations of refugee families and adding bus route signs and route maps at OMetro bus shelters.

**LB599 which restores prenatal care** to all women and babies in Nebraska was passed through the collaboration and work of OTOC and many organizational allies

#### Participation with UUA Doctrine of Discovery

The UUA Board of Trustees and the Prairie Star District Board has encouraged all congregations to study the Doctrine of Discovery so that delegates can be ready to vote each congregation's position at the General Assembly in June 2012. Our Social Justice Coordinating Council led our discussion and asked for feedback for our delegates. The Doctrine of Discovery has been used as the legal justification for the colonization of the Americas and the subordination of aboriginal peoples. The vote at General Assembly will be on a resolution to repudiate the Doctrine and encourage the United States to implement the United Nations Declaration on the Rights of Indigenous Peoples. Our feedback to delegates is that we agree in principle with the resolution but have some questions about specific wording.

#### **UUA Study/Action Issues**

In fulfillment of our Fifth Principle of Participation in the Democratic Process, the Social Justice Coordinating Council organized the

discussion and voting on proposed major issues (called Study/Action Issues). Delegates to the General Assembly in June 2012 will select one issue from five proposals. The Commission on Social Witness will then distribute research materials for congregation to use for discussion and study. After three years of feedback by congregations the Commission on Social Witness develops wording (called a Statement of Conscience) that states the UU position and local actions on the issue. Feedback to our delegates for priority order of support for new issues: Exploring Class Barriers; Reproductive Justice: Expanding Our Social Justice Calling; Ending Slavery; Families, Population, and the Environment; Climate Action and Adaptation Plans.

Feedback was also submitted feedback to the UU Commission on Social Witness pertaining to the wording of the Statement of Conscience for Immigration as a Moral Issues.

#### **Future Goals**

In looking to the future for justice-making at Second Unitarian Church, we recognize the need to engage the congregation in a meaningful discussion about what that means for us, the entire congregation and reflect on where we have been and where we want to go. It has been a number of years since the Social Justice Empowerment Retreat was held and it is time to explore the possibility of doing a similar retreat to engage members, affiliates and friends of Second Unitarian Church in this important work, and in so doing, affirm the continuation of the current social action groups, and perhaps expand or re-think the possibilities.

#### **Summary of Achievements**

- Finding Our Greatness was the theme for our Stewardship campaign. The theme was chosen to inspire us to let the light of liberal religion spread throughout our community—to be a "beacon of hope" to many more people. After two years of one-on-one stewardship visits with pledge households, this year the Team decided to invite members to attend "house meetings" where we created and deepened relationships as well as reflected on the work of Unitarian Universalism and our congregation. The discussions were framed around three words that sets us apart in the world: Authentic, Compassionate, and Transformative. There were 10 house meetings with a total of 75 members and friends participating. Results ("themes") from the house meetings were shared with the Board and Committee on Ministry.
- The Kick-Off Event for the Stewardship Campaign was held the evening of Saturday, February 25<sup>th</sup> at the Miracle Hills Golf and Tennis Club. It was a fun and festive event that promoted growth of relationships in our church community with Merry Barney, Sue Aschinger, and Becky Scherbring as testimonial speakers. Desserts and beverages were served.
- Sue Aschinger trained our 22 Visiting Stewards who canvassed 108 households and friends of the church inviting them to participate in the house meetings and making one-on-one visits with those who couldn't.
- As of April 29th we received 79 pledges totaling \$165,066, an average of \$2,089 per pledging household! This was 93% of our \$178,000 goal and an 5.3% increase over the amount pledged last year. We have once again demonstrated an exceptionally strong level of pledging in response to our deep commitment to our mission.

#### **Future Goals**

In addition to recruiting new Task Force members, we plan to meet with the stewardship leaders at First Unitarian and Lincoln Unitarian churches to get ideas for making our stewardship

campaign even better next year. Within the next two or three years we may be assisting with a Capital Campaign.

To provide a historical perspective, the year end financial information for the previous two years is included in this annual report.

#### <u>Presentation of Fund Balances as part of Consolidated Balance</u> <u>Sheet</u>

The Consolidated Balance Sheet shows the restricted and unrestricted funds in both the assets and liabilities/members' equity portions of the balance sheet. As of 4/30/2012, Checking and Money Market Account Balances total \$64,956.06. \$46,509.02 is Restricted Funds. \$18,447.04 is Unrestricted Funds.

In addition it recognizes the prepaid pledges as payable in 2012-2013. To accurately report these as pledges paid in 2011-2012 for 2012-2013, this amount is recorded as a Liability (Payable). Prepaid pledges will be transferred to Pledge Income in the next fiscal year of 2012-2013.

<u>The Endowment Fund</u> – Fund 03 is detailed on the Consolidated Balance Sheet. Included in the Endowment Fund are investments in the Vanguard Group, the donated Jefferson Pilot Annuity and the

donated 5 shares of Citigroup stock. In May, 2011, the 50 shares of Citigroup Shares were converted to 5 Shares. As per the accountant's recommendation, in September, 2008, the investments are marked to market:

- Interest / dividends are recorded as capital gain or loss monthly as well as any fees.
- Changes in market value are recorded as "Unrealized Gain or Loss" account on a monthly basis (except for the Jefferson Pilot Annuity which is annual).
