Minutes of 2019 Annual Meeting

Meeting was called to order at 12:04 PM by Steve Abraham, Chair of Board of Trustees. Tom Peterson, Secretary certified that a quorum of 59 members were present, exceeding the 39 required (35% of 110 eligible voting members).

Steve introduced Greg Minter serving as Parliamentarian, and Craig Piquette, serving as Keeper of the Covenant.

Unison Opening Words and Chalice Lighting were led by Rev. Cyndi Simpson, followed by a unison reading of the Covenant of Right Relations.

Judy Eller, incoming Chair of Nominations and Leadership entered a motion to nominate the following slate of elected offices:

Board of Trustees – Sue Aschinger, Ed Bok (3 year terms); Carol Johnson (1 year term) Nominations and Leadership – Julie Kirn (3 year term)

Endowment Committee – Jan Afrank (3 year term); Phil Phillips (1 year term) Motion was seconded by Chris Peters. A motion was made by Greg Minter to elect the slate by acclimation. Second by Clyde Anderson. Motion passed unanimously. Steve Abraham nominated Ruth Corwin, Vicki Pratt, and Cheri Cody to serve as Delegates for Second Unitarian Church at this year's General Assembly. Greg Minter moved to elect Ruth, Vicki, and Cheri as delegates. Second by Wesley Morrison-Sloat. Motion passed unanimously.

Tom Peterson presented a brief update from the Property Improvement Ministry. Bids have been received, but not yet finalized, from the general contractor and plumber. Bids for the parking lot were higher than expected, but the PIM wants to review the bid in detail to determine if any cost savings can be found.

The proposed budget for 2019-2020 was presented by the Board of Trustees. After introductory remarks by Steve Abraham, Tom Peterson, and Joe White, the budget was distributed to those in attendance. A motion to accept the budget was made by Wesley

Morrison-Sloat, and seconded by Julie Kirn. Joel Haskins introduced an amendment on behalf of the FCC: "We move to amend the motion on the floor. The proposed budget shall be approved to be in effect only from July 1 until August 31, 2019, and that the Finance Council and the Board, in collaboration, be given that amount of time to prepare a revised balanced budget to remedy the situation. Additionally, effective immediately, and extending until a balanced budget is approved and goes into effect, the Board may not approve nor sign any contracts that extend beyond that time period." Motion seconded by Ed Bok. A prolonged period of discussion ensued. After consultation with Parliamentarian Greg Minter, the Board tabled the motion to approve the proposed budget, ending debate.

Pam Curtiss-Smith made a motion for a continuing resolution to pay the bills as though a continuation of the 2018-19 budget, consistent with spending rates. Second by Cheri Cody. After a period of discussion, the question was called and seconded. Vote was in favor, and the motion passed with 57 in favor, 1 abstention.

Closing Words were read in unison.

Treasurer's Report

July 2019-June 2020 Cheri Cody, Treasurer

Our fiscal year is from July 1 to June 30. The following pages compare 2019-2020 amounts with end-of-year amounts for 2018-2019 and 2017-2018.

Consolidated Balance Sheet

The Consolidated Balance Sheet shows restricted and unrestricted funds in both the assets and liabilities/fund balances/members equity portions of the balance sheet. The Operating Fund 01 money is held in the checking account or money market account which includes everything except Endowment. This gives comprehensive and transparent reports by showing all transactions. Endowment funds are invested, restricted, and not liquid.

As of June 30, 2020, Checking, Money Market, Account Receivable, Capital Campaign Pledges, and Investment Accounts Balances total \$430,006.49 which includes Restricted Funds of \$439,156.19 (including investment funds) and Unrestricted Funds of \$32,121.53. The Endowment Fund is detailed on the Consolidated Balance Sheet. Investments are comprised of our purchases of Vanguard Group funds and our account in the UUA Common Endowment Fund. Changes in market value are recorded as "Unrealized Gain or Loss" account on a monthly basis on the balance sheet. Capital campaign:

Treasurer Duties and Responsibilities

The Treasurer is appointed annually by the Board of Trustees. Responsibilities include custodian of all church funds, weekly deposits, bill paying, record keeping for pledges and other contributions as well as financial data analysis, presentation, and retention, disbursements, plus preparing the workers comp audit report and other essential reports. I also administer payroll and ensure that the proper employee and employer forms are completed and payroll is submitted on a timely basis. The office administrator, Jaime Short, is responsible for day-to-day activities such as recording deposits, contributions, offerings, and paying invoices. In March of 2019 I assumed responsibility for the monthly bookkeeper responsibilities such as making accounting entries, reconciling the bank statements, and preparing balanced financial reports.

Summary of achievements:

- The committee meets on an ad hoc basis, typically to prepare for fall and spring cleanups.
- The fall workday was a success. The spring workday was not held due to Covid but a lot of trimming, edging, and tending to plants has been performed by members individually.
- A hail damage claim was finalized and work completed after a protracted negotiation with the insurance company and the contractor. The roof shingles & flashing were replaced and a full set of gutters installed. Replacement of signage, two windows, and damage to siding/masonry/paint were included in the settlement but left unaddressed beyond replacement of broken glass by church members. The unspent portion of the settlement was around \$4000.
- HVAC systems were inspected April 2019. The subsequent hail damage covered by the insurance settlement was limited a few hundred dollars to straighten the AC compressor fins. The HVAC repair crew declined to make this repair and claimed (but provided no evidence to substantiate) the 2012 unit was beyond repair. No satisfactory resolution was reached. The unit has since performed adequately.
- The exterior paint on the church (dating back to the 1960's) tested positive for lead.
- A sagging section of the ceiling tiles in the basement was repaired.
- A stair railing post on the front entry was repaired.
- This winter the new parking lot was treated with sand rather than salt to avoid surface damage while the concrete is still curing.
- New water and power sensors provided by our insurance company were installed in place of older technology.
- Members spent several days cleaning up after rainwater flooded the basement again.
- Several members participated in a Habitat for Humanity building effort.
- Two damaged trees by the compost bin and at the southwest corner of the lot were removed with the efforts of members, OPPD, and our neighbor Dan Hanneman (for fire wood).
- The two sodium vapor lights at the main entrance were replaced with new LED fixtures.

Future goals:

- Repair chimney masonry
- Paint or reside church exterior

Other information:

 A list approaching a hundred tasks (many reoccurring) is maintained to provide a work agenda for the spring and fall cleanup" days.

Caring Committee

Summary of the past year's achievements:

- As Joys and Concerns were eliminated from Sunday services, communications with congregants dropped significantly. From July 1st, 2019 through June 30th, 2020, we sent 18 cards to members who were celebrating joys or dealing with illnesses, deaths, and other sorrows. We also reached out to six people through calls, e-mails, and visits.
- We included Pat Hart's Go Fund Me site information in Caring Connections of the Enews.
- We donated \$25 that Shirley Rundquist gave to us after Tom's memorial to the miscellaneous line of the budget.
- Kathie added names to the Memorial Plaque to get it up to date.
- Kathie stepped down as chair at the end of Oct. 2019.
- Alana resigned from the Caring Committee in Nov. 2019.
- Dorothy and Lolly agreed to act as co-chairs beginning Nov. 2019.
- We clarified our explanation of transportation in our Caring Committee Guidelines since there was confusion around that.
- We completed a revision of the Caring Committee Guidelines and needed one more review before presenting it to the board for approval.
- Two congregants had serious health issues that we addressed with our volunteers.

- The Buddy System was started, resulting in 14 congregants paired to support each other during times of uncertainty.
- We did not plan any presentations as our budget allowed due to the many changes we were experiencing.
- We announced to the Committee Leadership Council in June that the Caring Committee was officially inactive because of COVID-19.
- Dorothy announced that she was stepping down as co-chair in June to focus on her upcoming role on the board.
- Lolly announced that she was stepping down as co-chair in June.
- Both Dorothy and Lolly have offered to assist the committee when it becomes active again, which may not be until COVID-19 no longer restricts activities.

Future Goals:

- Without the enthusiastic support of a church minister, and without a welcoming
 environment where congregants feel safe in sharing their joys and sorrows, we are
 uncertain of the future of the Caring Committee. If and when the committee becomes
 active again, Dorothy and Lolly will offer their assistance to the new chair and
 members when asked.
- To finalize the revised Caring Committee Guidelines, making any adjustments needed "post-COVID-19" before presenting it to the board for approval.

estimates came in a LOT higher than when the first estimate was done so that meant another pledge drive would need to be done to bridge the gap (analysis showed we could not easily afford a bank payment from our annual budget).

- With help from Kathy Bell, we created a donate button on our web page.
- Made sure an official financial audit of our books was done for 2016 2019.
- Had the piano appraised to be sure it was covered by insurance.
- The FCC and the Human Resources Council (HRC) to move forward from the last Congregational Meeting (held prior to July 1st, 2019) where the FCC stood in opposition to the Budget as proposed by the Board.
- Investigated Chalice Lighters regional funding program to help pay for property improvements (we are not eligible for that program after all).
- The Endowment Committee held a promotional event called "Blue Boat Home" to raise awareness and money for the Endowment funds.
- Discussed implementing a 2-year budget so we could more easily identify risks and benefits of using previously un-spent budgeted money, and so we could identify and prepare for longer-term expenses.
- Vicki organized the viewing of 6 UUA hosted webinar presentations which focused on the things small congregations can be very good at achieving. All webinars were very well done and there was very good attendance.
- Refilled the hymnals with offering envelopes when needed.
- Our Treasurer, Cheri Cody, provided detailed treasurer reports each month for the FCC to monitor and help identify any number of financial issues including accounting methods, bill-paying, salary payments, tax payments, budget overruns, income short-falls, etc. Cheri deserves a lot of thanks for handling payroll for our staff!
- The Endowment Committee handled a donation from Al Harrison's estate which was invested according to Unitarian Universalist values.
- Helped develop a proposed budget for 2020-2021 taking into consideration
 possibly big changes in giving due to the pandemic. A small team consisting of
 Rev. Simpson, Tom Peterson, Cheri Cody, and Vicki Pratt helped develop 3
 different plans for what we would do if giving dropped making it impossible to
 maintain the current budget.
- Acting on behalf of our church, Cheri Cody applied for and received grant money from the US Government's Payroll Protection Program (PPP). This money paid salaries and certain other expenses for 2 ½ months (because of the pandemic).

- Due to Pandemic Covid 19 some activities were canceled, and it was difficult to finish pledge meetings and track down pledge forms. (Building closed March 13)
- Thank you letters mailed out mid-June.
- Did not get to have final after church thank you celebration, meaning no cake!
- Due to issues within the church and the volatile financial issues caused by pandemic, we lost some major pledgers or people lowered their pledges. Budget had to be reduced by 15%.

MAC Communications Policy: We made a few changes to our policy and submitted them to the Board. Changes included moving the worship cancellation policy to the board, and tightening up verbiage regarding the newsletter and electronic communications.

Promotions and Advertising: Opportunities were unusual this year as COVID-19 forced us to change some of our plans. We continued our weekly on-air radio promotion on KIOS during the All Things Considered time slot. The River City Mixed Chorus, which we have supported for years with First Unitarian, cancelled their shows. Instead of a refund, our committee decided to keep our commitment to them as a demonstration of our support. Omaha Gives, a fundraising opportunity run by the MAC, did double



duty. We were planning on making yard signs (see image) for congregants and decided to use this as a promotional vehicle for Omaha Gives so that any donor receives a free yard sign. Additionally, we sent out postcards to members to provide a physical reminder of the event. We ended up raising \$3,760 from 33 donors on that Wednesday, and then had more people who gave after the event because they were so excited about the yard sign. Finally, with quarantine as a result of COVID-19, we feel it is important to reach out to our immediate community in the neighborhood. We started the process of making a sign that spreads the good news of organic gardening while promoting available plots.

Online Giving: We provided assistance to the Finance Committee by setting up and promoting Vanco's online donation screen on the church website. In conjunction with this, we expanded the Giving menu to also include pages on why we give, giving options, pledging, and planned giving/endowment fund. Fortunately, this months-long project came to fruition just as our in-person worship services had to be suspended due

to COVID-19 and has provided an easy way for people to continue donating during online/zoom worship services.

Website Privacy Policy: We submitted to the Board a new website privacy policy, modeled after a sample provided by the UUA. The Board approved the policy in November.

Summary of the past year's achievements:

Revision of Standing Rules: Standing rules were revised to reflect the Visitor to Membership Protocol. Those were approved by the Board in Sept of 2019.

EnqUUiring Minds: The format was changed to have it on 1- day verses multiple days. This was led by Rev Cyndi on July 27 from 9am to 4 pm. Six visitors attended. EnqUUiring Minds was held on Saturday, January 4 with 3 visitors attending. Morning snacks & lunches were provided by the Membership team.

Lost Sheep Review: We reviewed our membership of 109 people and identified those who we hadn't seen recently. Each of the 9 people identified was assigned to a committee person who reported back their findings at the Oct & Nov meetings.

It was noted that six of the members who left last year (three couples) had young children. There is a R.E. re-visioning effort in process.

Second Sunday Lunch (After-Worship lunches)

10 people came to the August lunch & the Sept lunch did not take place due to an Art Fair. In Oct we had 4 people and had to cancel the Nov & Dec due to Congregational Meeting & Townhall.

Curriculum Evaluation:

JoAnne met w/ Lincoln UUs & 1st Church on Oct 24th, 2019. Lincoln uses the *Starting Point Curriculum*. This is designed to integrate newcomers into small group ministry. Our committee did purchase Starting Point. We decided that Starting Point sessions I and II are already covered in our EnqUUiring Minds. In reviewing Starting Point sessions III and IV these focus on listening, being open & serving. We decided not to pursue this & to follow last fall's advice of the UUA small church webinar which urged small churches to focus on a few things and do them well.

It was decided that a good, manageable step is to offer *A Taste of Soul Matters once a month after the church service,* as a way to invite members to the sacredness of deep listening, to explore small group ministry and to make meaningful connection. Anita will work on a plan.

Circle Suppers – 51 people are participating in 6 Circle Suppers in Oct thru Nov. Twice a year seems to be a good schedule for the suppers & makes recruiting hosts very doable. Jan thru Mar we had 7 suppers scheduled w/ 47 participants however 3 dinners were cancelled due to Covid-19.

Programs & Covid 19: Struck the country the middle of March and crippled our current programs.

There were no on-line services from March 15th through May 10th. Services started back up on May 17th via Zoom.

The NLC worked with the Finance Council to identify and invite individuals to attend the webinar series on small congregations.

Four excellent candidates were recruited for positions on the Board (Dorothy Danielson, Pam Curtis-Smith), Endowment Committee (Rod Baumann), and NLC (Pete Miller).

Property Improvement Ministry

Committee Members: Clyde Anderson (Buildings & Grounds Rep) JoAnne Draper Convener, Tom Peterson (Board), Justin Short 2019-2020 achievements:

- During July & August the Team recruited four contractors to review the project plans, visit the church, and submit bids.
- Three of the four contractors submitted bids, and on Sept. 15 Diversified
 Construction was selected with a bid of \$240,677 -- \$126,400 for the Parking Lot
 Replacement and sewer (Phase 1) + \$114,277 for the Bathroom Addition (Phase
 2).
- Since the bid was \$100,677 more than PIM Team's \$140,000 estimate, a proposal was made and approved by the Congregation at a Dec. 8 meeting to extend the Nuu Way Capital Campaign a fourth year to Dec. 1, 2022. By June 20, 2020, the Capital Campaign pledge total had reached \$274,824!
- Demolition of the old parking lot began Oct. 22, and by Nov. 8 the new concrete parking lot was completed and in use. For two Sundays it was necessary for church attendees to park on the street and in nearby parking lots.

- At the Dec. 8 meeting of the Congregation, several members suggested that the PIM Team look at a larger Phase 2. Kathy & Rick Bell developed a plan with approximately three times the floor space that would include a meeting room and small kitchen. A rough estimate by the contractor determined that the Expanded Phase 2 would cost about \$166,000 more than the original plan. At a Town Hall meeting Jan. 12, the Board announced that we would proceed with the original plan which followed the original 2017 directive to the PIM Team.
- Construction of Phase 2 began on June 10 after considerable delay due to the COVID-19 pandemic. Completion is expected by late Summer 2020.

Future goals for your committee for 2020-2021:

- Complete construction of the Bathroom Addition

Summary of the past year

- Jim Poleshuk officially resigned as chair.
- Budgeting for the Open Arms Trans social group changed this year and lunch expenses were included in the social justice budget and childcare in the church budget. OATS continues to provide a safe space for transgendered youth. They secured a new domain for the OATS website. Over time, OATS has shifted from trans youth and young adults to elementary-aged trans children, their parents and siblings but this is not static; young adults still attend. This year, OATS provided a monthly lunch for attendees and family members. Pre-pandemic, attendance was around 30 people; with the pandemic there are fewer participants over Zoom.
- The Second U OTOC Core Team participated in Leadership Development and other training opportunities available through our congregation's membership in Omaha Together One Community, the local congregation-based community organizing group.
- Each year OTOC congregations conduct an internal contribution campaign where letters are sent to a targeted group of members in the congregation. The letters are signed by members of the OTOC Core Team within Second Unitarian Church. This year, the OTOC Individual contributor campaign raised \$1445.
- In December, the committee held a potluck "meet and greet" at Second Unitarian with new OTOC organizer, Sarah Keeney. Everyone in the congregation was welcome to attend but there was a small group of 8 or 9. We also set one-to-one meetings for church leaders to talk with her, further building Second Unitarian's relationship with OTOC.
 - Vicki Pratt, in particular worked with OTOC, to help get payday lending interest caps on the November 3, 2020 ballot.
- The committee made plans to donate a basket for the OTOC auction.
 The auction was delayed due to the pandemic but items (books, wine, spaghetti sauce, chocolate, salsa, jazz CD and movie) were purchased for the Nebraska themed basket valued at \$105.
- Practiced social witness by displaying banners on the church building supporting Black Lives Matter and Compassionate and Just Immigration Reform.
- Managed the community garden and provided ground tilling and water for the 14 community plots.

- Participated in the Faithful Builders coalition for Habitat for Humanity. Clyde
 Anderson coordinated volunteers and wrote articles about the house and family
 during the months of the build.
- For over a year, Second Unitarian has adopted a sanctuary family and every other week members donated food items (as requested by the family). When the pandemic hit, the sign-up form was changed so that people committed to making a cash donation rather than a food donation. This effort is coordinated by Monica Meier and Kael Sagheer who now also assist with the shopping since the switch to money rather than food.
- Cheri Cody and others participated in the Omaha Community Council for Racial Justice and Reconciliation. The Council commemorated the the 1919 lynching of Will Brown, but its purpose is also to foster discussion and racial healing in Omaha.

Future goals:

- The committee would like to involve more congregants outside the social justice committee in justice work. Plans had been made to form a "strategy group" to ask people what social justice means to them and what they'd like to see us do. A meeting time was set for the end of March 2020 but was canceled when the pandemic hit.
- The committee has discussed wanting to engage more people in the congregation through education, by hosting Civic Academies or social justice book clubs via Zoom.

Summary of the past year's achievements:,

This committee, which meets on the first Tuesday of each month, is responsible for planning services and finding speakers for each Sunday that Rev. Cyndi Simpson is not in the pulpit, as well as completing the paperwork for outside speakers and musicians. Due to the COVID-19 pandemic, Sunday services were suspended and Rev. Our Music Director, Donna Zebolsky, has been relieved of her duties as well as we have no need of her services or that of guest pianists during this time of pandemic. Sunday services are planned using Soul Matters monthly themes.

Statistical information

Attendance to Sunday services from May to August have varied from the low 50's to upper 60's, which is lower than regular attendance in the high 60's or 70's on a typical Sunday.
