No regular meetings or classes

Social distancing of 6 feet or more

Masks required in the building except staff working alone, or unless volunteer working on a ladder

Limited outdoor events - Garden fundraiser and RE events, weather permitting, at the discretion of the Board

Worship service prep (recording music and distanced unmasked singers) permitted (with stipulations)

Services online only

RE meets monthly, outdoors weather permitting (with RE stipulations)

Office Administrator should work on site if not quarantined, other Staff who can work remotely should do so

Contractors and volunteer workers allowed (with building entry stipulations)

No rental activities

Meetings of 10 or less may meet spread out in sanctuary (with building entry stipulations)

Social distancing of 6 feet or more

Masks required in meetings unless presenting. Replace mask when finished speaking

Limited outdoor events - Garden fundraiser and RE events, weather permitting, at the discretion of the Board

Worship service prep permitted (with music production stipulations)

No live singing during worship services

No fellowship gatherings

HVAC should be run and/or windows open for filtering and ventilation during sanctuary events

150-299 cases per week* in Tri-County Area

Hybrid services, limit of 25 in sanctuary; no vespers until September at least. Sunday adults only unless an RE Sunday

By registration only. Priority given to families with young children on RE Sundays.

RE meets monthly, outdoors weather permitting, (with RE stipulations)

Office Administrator should work on site if not quarantined, other Staff who can work remotely should do so

Contractors and volunteer workers allowed (with building entry stipulations)

No rental activities

Meetings of 25 or less may meet in sanctuary (with building entry stipulations)

Social distancing of 3 feet or more

Masks required in meetings unless presenting. Replace mask when finished speaking

Limited outdoor events - Garden fundraiser and RE events, weather permitting, at the discretion of the Board

Worship service prep permitted (with music production stipulations)

No live singing during worship services

No fellowship gatherings

Chairs arranged in five columns, singly in 5 rows, households can rearrange chairs to sit together

HVAC should be run and/or windows open for filtering and ventilation during sanctuary events

50-149 cases per week* in Tri-county area
Hybrid services, limit of 50 in sanctuary; no vespers until September at least
By registration only. Priority given to families with young children on RE Sundays.
RE meets monthly, outdoors weather permitting (with RE stipulations)
Staff may work on site if not quarantined unless working from home is warranted
Contractors and volunteer workers allowed (with building entry stipulations)
Rental activities may resume at the discretion of the Board (with building entry stipulations)
Meetings of 25 or less may meet in sanctuary (with building entry stipulations), downstairs meetings are ok
Social distancing of 3 feet or more
Per UUA guidelines, masks required in meetings unless presenting. Replace mask when finished speaking
Outdoor events will be reviewed as requests are presented
Worship service prep permitted (with music production stipulations)
No live singing during worship services
Fellowship gatherings only outdoors
Chairs arranged in four columns by couples, 6 rows. Families with kids can drag a chair or two from nearby
HVAC should be run and/or windows open for filtering and ventilation during sanctuary events

10 to 49 cases per week* in Tri-county area
Hybrid services - Limit of 75 in sanctuary; no vespers until September at least
First come first served
RE resumes normal activities, including vespers
Staff may work on site if not quarantined unless working from home is warranted
Contractors and volunteer workers allowed
Rental activities may resume at the discretion of the Board (with building entry stipulations)
Meetings may occur downstairs or in sanctuary/library
Social Distancing at the discretion of the individual. Ask for consent before violating someone's space.
Per UUA guidelines, masks required in meetings unless presenting. Replace mask when finished speaking
Outdoor events will be reviewed as requests are presented
Live singing (solos or spaced choir) permitted
No congregational singing unless protocols are revised
Fellowship gatherings can resume indoors
Chairs in a more normal configuration, albeit fewer rows, or rows spaced out more than usual
HVAC should be run and/or windows open for filtering and ventilation during sanctuary events
