## Minister's Discretionary Fund Policy

The use of the Minister's Discretionary Fund (hereafter MDF) is at the minister's sole discretion. However, the primary intent is for Members or Affiliates of the congregation who are experiencing short-term financial hardship to be the recipients of the Fund. Any MDF payments made to an employee for emergency assistance are taxable and the receipt needs to be submitted to the treasurer for entry on payroll,

Discretion should be used when an occasional non-member experiencing short-term financial hardship approaches the Church. In this case, the Minister should verify that all other community resources have been exhausted. Funds should be issued only once to the non-member. If another request for funds is made, it is recommended that the recipient check other community resources listed below. (See Resources listed).

Conservation of the MDF account should be practiced since this fund does not appreciate quickly. Consideration should be given to paying a percentage of a utility bill, rent, etc. to stretch the funds to assist multiple people. The MDF account is dependent on individual contributions and special offering collections.

In each case, the distribution must be in keeping with the tax-exempt purposes of the Second Unitarian Church of Omaha, as defined in its Articles of Incorporation and By-Laws. These purposes allow assistance with short-term financial needs such as: food, shelter, clothing, medical expenses, and transportation.

It is the intention of the Board of Trustees that this policy comply with the US Tax Code to reduce possible financial liability to the Minister and those who donate to the MDF.

It is the intention of the Board of Trustees that this policy allow for the highest level of pastoral confidentiality; that is, no one will know who the Second Unitarian Church member, affiliate recipients or non-member of funding are, other than the Minister.

It is the intention of the Board of Trustees that under no circumstances can the Minister or members of the Minister's family be recipients of funding from the MDF.

To ensure that the Congregation has full control of the use of the MDF through its Board of Trustees, as well as that pastoral confidentiality is held for Second Unitarian congregational members and affiliates who receive funds from the MDF: no less than twice a year, or at any time at the request of the Chair of the Board of Trustees, the Minister and the Chair of the Board of Trustees shall review the use of the MDF. All information requested as to the use of the MDF will be provided by the Minister, other than the names of Second Unitarian congregants who have received money from the MDF.

The MDF is held in a separate checking account, titled *Second Unitarian Church Minister Discretionary Fund* at Core Bank in Omaha. The checkbook and statements are held in a locked file cabinet in the Minister's Office. The Minister and the Treasurer receive copies of the monthly financial statements of the MDF account.

The checks written on the MDF require only one signature, which will usually be the Minister. The Treasurer or Chair of the Board of Trustees also has signing authority for use during times of ministerial absence. During a ministerial absence, the Chair of the Board of Trustees shall assume the minister's role in disbursing funds from the MDF, in accordance with these policies. In these cases, the Chair of the Board of Trustees or the Treasurer will have the authority to sign MDF checks.

In all cases where it is possible, the Minister should give MDF funds indirectly to recipients rather than directly. That is, if rent is being paid, the check should be made out to a proprietor. In these cases of indirect support, a receipt should be requested as documentation.

Sometimes it is not possible for a check to be used, such as when a recipient is requesting financial support through a crowdfunding website. In cases where the use of a check is not possible, the Minister may use their church-issued credit card, and then reimburse the Congregation through writing a check from the MDF to the Second Unitarian Church of Omaha. The debit card tied to the MDF may also be used, however, these debit cards are not as secure as a credit card, and the bank does not usually cover the losses. A receipt is always required when the Minister's credit card or debit card is used. The receipts for each event must be stapled to the appropriate bank statement.

Under no circumstances is the Minister to withdraw cash from the MDF account to give to an individual needing assistance. A check or a church credit card must be used. A debit card may be used but the reason (Gas, food) must be noted on the copy of the payment receipt.

Each week, one-half of the offering is set aside for Share the Plate which the MDF receives on the 5<sup>th</sup> Sunday four times a year. The Minister's Discretionary Fund will receive one-fifth of the total set aside in months when there are five Sundays, with the remaining four-fifths of the set aside designated for the Social Justice Committee's current Share the Plate funding partner.
